Policy respecting the protection and enhancement of the natural environment

At the request of Montréal's Executive Committee, the Office de consultation publique de Montréal (OCPM) will hold a public consultation on the *Policy respecting the protection and enhancement of the natural environment.*

PURPOSE OF THE CONSULTATION

The Draft *policy respecting the protection and enhancement of the natural environment* aims primarily to improve Montréal's living environments in order to protect natural areas, and to enhance them for the benefit of Montrealers. In establishing this policy, the City targets three major objectives:

- To maximize biodiversity and increase aggregate hectarage of protected natural spaces in Montréal;
- To foster enhanced integration of ecosystems and natural landscapes in built-up areas;
- To ensure sustainability of the natural environment in City parks, and promote the consolidation and viability of park ecosystems.

This Policy is part of an integrated land-use planning approach, and is in keeping with a vision of sustainable development and urban fabric consolidation. It would make Montréal more attractive by creating spaces sought by residents, visitors and organizations alike. It would also contribute to the development of a concerted approach mobilizing corporate departments, boroughs, environmental groups and developers in a common land-use planning project.
