



## Public Consultation

### Draft By-law P-04-047-60 Plan to introduce new Mount Royal protection and enhancement measures into the Master Plan complementary document

Draft By-law P-04-047-60, entitled "Règlement modifiant le Plan d'urbanisme de la Ville de Montréal (04-047)," was adopted by city council at its meeting on February 25, 2008.

The Office de consultation publique de Montréal (OCPM) will hold a consultation on this draft by-law and make relevant documentation available to the public.

#### ***PURPOSE OF THE CONSULTATION*** **Amendment to the Master Plan**

Draft By-law P-04-047-60 provides for required adjustments to the Master Plan of the City of Montréal to allow the implementation of the Mount Royal Master Protection and Enhancement Plan. The protection measures outlined in the protection and enhancement plan have to do with natural environments, built and managed environments, and landscapes, including views available of and from the mountain. To ensure consistency between the outlined protection plans and borough by-laws, it is proposed that the complementary document to the Master Plan be amended to include protection measures, which would then be transposed to the borough by-laws. The amendments to the complementary document involve heights, implementation rates, natural environments, protected green spaces, land development and the installation of mechanical equipment.
