Hi. My name is Pinto. Bonjour. My name is Nalawattagee Pinto and Côte-des-Neiges has been my home for 28 years. In that time, I had many troubles in housing.

1270

When I first came to Canada, we did not know how much a three and half cost. Landlord ask: « how long in Canada?, I say last week and they say: welcome to Canada! », and give me a really high rent.

1275

I had no other options, so I was forced to accept this situation. Since then, it has only gotten worse. You can't ask anything from landlord. If you say something, ask for repairs, say no rent increase, they try to kick you out as soon as possible.

If you leave this apartment, forget it, your rent will be much higher than before. You are lucky if you find an apartment or you are homeless.

1280

Homeless people are just like you and me before.

In the time we have been fighting for Blue Bonnets, rent for three and a half has gone from 300 to 900 dollars. Three times more.

1285

A lot of people are suffering to find good apartment in Côte-des-Neiges. 2 436 families are waiting for low cost housing, waiting on average five years.

Blue Bonnets can be a solution to this. Right now, the poor in Côte-des-Neiges are being pushed out. Low cost housing will answer the needs for many people.

1290

This is our first and last chance. No more big land in Montréal.

We must fight now. Côte-des-Neiges is speaking up and we need the City to listen. We need the social housing. Housing are rights.

1295

We are glad you are doing this consultation, but we need more. The City has to act, not go to sleep and after listening to all of us. Otherwise when they wake up, it is too late, it is all condos. We do not need a condominium city in Montréal. Thank you very much.

Low cost, like I think they say all is affordable housing, this is just like words. I don't...

... trust this politician word. Sometimes people are talking about middle class, poor and rich, no middle class in this country. Even I know, there are no houses for, low income houses in this country. It was in HLM, now HLM is dead.

And you think there are many people like you who wouldn't trust anymore of the system to offer good conditions for living?

#### M. NALAWATTAGEE PINTO:

No, because I think it's Montréal they try to do private housing to, for more people to live a good in a good apartment, but it is like a business. We don't hope. This business is for just (inaudible), you know. Not we think about the low cost housing, HLM is the best for security and clean and management. They look at our income and they give you 25 % of rent. If you increase the income, they increase the rent too.
