Draft By-law P-06-044

Draft By-law authorizing the demolition of certain buildings and the transformation, expansion and construction of other buildings at the Centre hospitalier universitaire Sainte-Justine

Draft By-law P-06-044 titled « By-Law relative to the demolition of the building located at 3201 Côte-Sainte-Catherine Road and part of Wing 8 of the building located at 3175 Côte-Sainte-Catherine Road, and the construction, expansion, transformation and occupation of the Centre hospitalier universitaire Sainte-Justine at a location situated at 3175 Côte-Sainte-Catherine Road, and another location situated at the Northwest corner of McShane and Ellendale Avenues » was adopted by city council during the meeting on October 30th, 2006.

The Office de consultation publique de Montréal (OCPM) will hold a public consultation on this draft bylaw and is making relevant documentation available to the public.

PURPOSE OF THE CONSULTATION


Adoption of a draft by-law pursuant to section 89 of the city of Montreal charter

Draft By-law P-06-044 is aimed at allowing the construction, demolition, expansion, transformation and occupation of institutional buildings belonging to the Centre hospitalier universitaire Sainte-Justine on land subject to the application of the by-law.

The draft by-law includes provisions concerning building heights, placement, density, uses, apparent clearance allowances, margins, landscaping as well as loading zones and parking areas.

Draft By-law P-06-044 breaches certain provisions of the Côte-des-Neiges-Notre-Dame-de-Grâce borough urban plan (01-276). The draft by-law will allow the building of the project on the Mount-Royal heritage site. Subsequently, pursuant to section 89.5 of the city charter, it is subject to referendary approval.
