Keep All of Pierrefonds's Green for Future Generations

(1) Who Are We?

Comprised of over twenty students, the Herzliah Environmental Club was founded in 2006. The initial goal behind its foundation, to instill a recycling service, has grown exponentially, and now consists of encouraging and promoting environmental values both in school as well as in the community. This group of change-seeking individuals has partnered with many different organizations over the course of its existence, such as the Jewish National Fund and SOS Meadowbrook.

(2) Overview:

After having read the article published by John Meagher in the Montreal Gazette, "The Battle to Preserve Wildlife in Anse-à-l'Orme Begins Again", we felt not only the urge, but also the fervent obligation to do whatever was in our power to stop Grilli Development and its partners' project.¹ Once we heard that the OCPM is holding hearings regarding this company's "Camp Nature Project", we saw a window of opportunity that would permit us to defend our beliefs and stand by our values. We vehemently believe that the "Camp Nature Project" should be rejected, because going through with it would be harmful to the environment, destructive to the beautiful elements that compose our nature landscape, create financial damage to taxpayers, and destroy one of Montreal's touristic attractions.

(3) Details:

- University researchers conducted a study, discovering that over 270 different species of fauna and flora are occupying the Anse-à-l'Orme region.² Destroying all of this life could entail very negative repercussions to our ecosystem and our environment.
- Another study, by l'Institut des Sciences et de la Forêt tempérée, has revealed that the loss of this habitat to all that reside in it could risk severe damage to the ecological biodiversity of the Anse-à-l'Orme area.³
- Building this new infrastructure will cost the city lots of money. The expensive project will result in the bilking of money from taxpayers in the Pierrefonds-Roxboro area.⁴
- Preserving Montreal's touristic attractions is essential to maintaining our economy as well as our popularity. According to www.tourisme-montreal.org, "this linear park is a favourite of windsurfers and boaters, who come for the prevailing west winds".⁵
