Questionnaires on impressions of the pilot project




Would you say that the pilot project prohibiting transit traffic on the mountain is "a very good idea," "a somewhat good idea," "a somewhat bad idea," or "a very bad idea?"

Overall, 58.7% of participants thought that it was a very bad idea. The results vary depending on the respondent's means of transportation. The on-site answers are more positive, regardless of the respondent's means of transportation.

Questionnaires on impressions of the pilot project





Questionnaire on impressions of the pilot project - Online



55.2% of respondents "completely agree" and "somewhat agree" that the pilot project reduces the number of vehicles on the mountain;

48.4% of respondents "do not agree at all" that the pilot project improves the safety of the various users;

54.7% of respondents "do not agree at all" that the pilot project improves the efficiency of public transit;

55.7% of respondents "do not agree at all" and "do not agree" that the parking lots are easily accessible during the pilot project;

Questionnaire on impressions of the pilot project - Online



53% of respondents "do not agree at all" and "do not agree" that the pilot project improves the air quality and sound environment;

62.3% of respondents "completely agree" that the pilot project makes it more difficult to travel between the various points of interest;

67.5% of respondents "completely agree" that the pilot project has increased traffic in areas surrounding the mountain.



Overall reactions - Creative workshops

Transit traffic



Out of the seven groups, four chose to include among the three priorities of the workshop the reopening of the Camillien-Houde and Remembrance axis to through traffic.

In two of the groups, the participants did not reach a consensus on their position regarding the closure of the road to private vehicle through traffic. Those groups focused more on developments to improve the safety and co-existence of the various types of users.

Out of the seven groups, only one had a majority of members in favour of closing the Camillien-Houde and Remembrance axis to through traffic.

Creative workshops

3 findings of participants



- It was calmer and very enjoyable on the mountain this summer
- The pilot project made access to the mountain and travelling between the various points of interest more complicated
- Prohibiting through traffic, in the form proposed by the pilot project, did not improve the safety of the various users of the Camillien-Houde and Remembrance axis. Problems involving road sharing and dangerous behaviours persisted.




