

STOP is a non-profit citizens' environmental group located in Montreal. Incorporated in 1970, STOP deals with a wide variety of environmental issues, including air and water pollution, solid waste management, energy policy, and protection of green spaces.

STOP participated in the OCPM hearings held in November-December 2011 regarding the four proposed CTMO sites. Georges Hébert, STOP President, testified at the public hearing held in Dorval. Bruce Walker, STOP Secretary-Treasurer, testified at the public hearing held in Montréal-Est.

STOP supports in principle the City of Montreal's project to construct two composting sites and two biomethanization sites. The sooner such sites are built the better. More specifically, we are pleased to support the recommendations of the OCPM's Rapport de consultation publique, dated 20 March 2012. We urge this commission to examine this report in detail.

With regard to the proposed composting site in Saint-Laurent, we urge the City of Montreal/Borough of Saint-Laurent to ensure the continued existence of the buffer zone.

#### Odour Control

Odour-causing emissions from any industrial activity represent a potential risk. We support the implementation of the proposed odour control techniques. STOP strongly supports the installation of continuous,

real-time ambient air monitoring of odours around the Saint-Laurent composting site. We urge the City of Montréal to live up to its commitment to install similar "nez électroniques" at all CTMO sites, whether for composting or for biomethanization.

Comités de suivi

In section 3.2.3.1.1, the Rapport de consultation publique states:

**3.2.3.1.1 Les comités de suivi**

Une attention soutenue doit être apportée au mode de gestion des équipements afin d'assurer la plus grande transparence possible et l'accès du public aux informations pertinentes. D'un point de vue sociopolitique deux aspects sont essentiels : l'implication active du public à toutes les étapes dans le respect des droits de chacun; la reddition de comptes pour permettre d'évaluer l'atteinte des objectifs et d'assurer un contrôle démocratique.

STOP wholeheartedly supports the commission's views, and this

after many of participating on such committees (see Appendix).

STOP believes that each of the four proposed CTMO sites needs to have its own comité de suivi. STOP would be prepared to become a member of at least one of the four comités. Since, as the commission pointed out, there is no "one size fits all" approach to comités de suivi, STOP recommends that the City of Montréal consult with stakeholders who have real-world experience (e.g. industries, community & environmental groups) prior to the setting up of the CTMO comités de suivi.
